TERMS & CONDITIONS

CONFIRMATION & DEPOSIT:

Booking must be made with a 10% non-refundable deposit within 2 weeks confirmation.

BAR FACILITIES:

A minimum of 50 adults must be attending the function for the back function room bar to open, or a surcharge of \$30.00 per hour will be charged. It is against the licensing law to bring your own food or drinks onto licensed premises.

CONFIRMATION OF NUMBERS:

Final numbers attending the function must be advised **fourteen (14) days** prior to the event. A minimum charge will be made for the final numbers given (even if the actual number attending on the day is less than this number). Extras will be charged at the per head rate over the final numbers

DAMAGE:

Please note that the organisers are financially responsible for any damages to the property/equipment during the function. The venue will take necessary care but will not accept any responsibility for the damage or loss of any client's property in the function rooms before, during or after a function. Any breakages, loss or damage to equipment, facilities or linen will be charged to the client responsible for the function.

MENUS:

A final decision of the menu selection must be advised **eight (8) weeks** prior to the function being held. Alternate drop meals are served to the table 50/50. If a choice is required, there is an extra charge. Please advise if any guest(s) attending the function require special meals (for example; Gluten Free, Vegetarian or Nut Allergies). Leftover food is the property of the Lighthouse Hotel and is not to be taken off premises. Sundays and Public holidays attract a 10% surcharge.

MINORS:

Please note that it is an offence under the Liquor Act in this state for minors to consume alcohol in a licensed premises. We require minors to be identified attending any function and it is our policy minors be off our premises by 10:00pm on the night of the function.

PAYMENT:

Unless other arrangements have been made with Management, settlement of account and bar tab must be **seven (7) days** prior to the function being held. Our preferred payment option method is cash, eftpos or direct debit.

PRICING:
